Project Description

Eric Wright Construction has currently been appointed as Principal Contractor to continue to carry out the design work, and complete the enabling works (ground works) of the Beechmere re-build. The overall build contract is still out to tender but will involve building a c.132 apartment building for people aged 55 plus, in the same footprint as the original building.

Planned works over the coming month

Site establishment works will start with the installation of temporary welfare cabins and the clearance of shrubs and trees around the perimeter. The installation of perimeter fencing and replacement of existing fencing will follow soon after.

The demolition contractor will begin breaking up the concrete slabs at the beginning of March. A process that is expected to take approximately seven weeks.

Questions & Answers

Will there be any noisy periods?

Yes, however the works will be kept within the agreed time periods in line with local planning restrictions. Where possible we will use the quietest plant and equipment available and utilise sound muffling techniques to reduce noise.

How will any wind blown dust be dealt with?

We are committed to keeping our site as clean and dust free as possible. During the demolition, the dust will be controlled via the use of water suppression whilst the areas of the building are demolished.

Will there be any problems with mud on the road?

Eric Wright Group Ltd will ensure that the working machinery, plant & vehicles, which may have the potential to cause an excessive dust or mud problem onto the public highway, will have the facility to wash down. This will be placed at a strategic point near to the road exit of the site, to prevent the mud being carried on to the road. If the road does get muddy, a road sweeper will be used to clean it.


